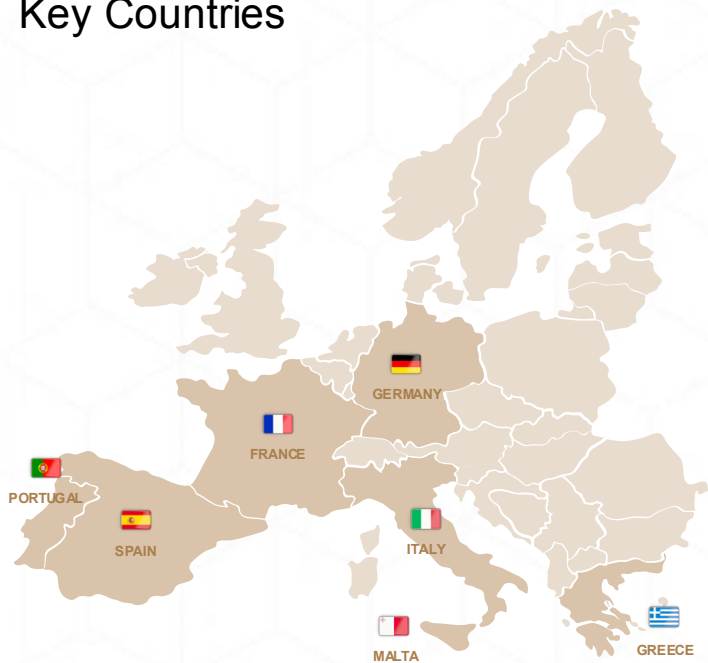

Basic requirements for all programs

- Meeting the requirements and conditions of the selected program
- Residing in the country of residence permit for at least 183 days
- Having a registered address in this country (long-term lease or purchased real estate)
- Taxes payment

- Income greater than EUR 1,800 per month or greater than EUR 21,000 per year; availability of savings in a deposit account is to be confirmed
- Real Estate in France to be purchased or rented and health insurance obtained

- A residence permit is issued for 1 year, with the possibility of extension
- Visa-free travel to European countries
- Immigration for the entire family
- Transition to permanent residence | citizenship after 5 years

Financial sovereignty

Requirements

- Stable recurring revenue of EUR 820 per month outside Portugal.
- Savings in a personal bank account in Portugal of at least EUR 9,840

- The validity period of the residence permit is 2 years, with the possibility of extension for 3 years
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Requirements

- Remote income of EUR 3.280 plus per month
- Savings in a personal bank account of at least EUR 9,840

Program specifics

- The residence permit is valid for 2 years, with the possibility of extension for 3 years
- To extend, the requirement is to reside for at least 1.5 years or 16 months within 3 years
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Financial sovereignty - Elettiva

Requirements

- Stable recurring revenue from abroad of at least EUR 31,160 per year
- Rent or purchase of real estate in Italy

Program specifics

- Residence permit valid for 1 year, with the possibility of extension
- To extend, the requirement is to reside for at least 183 days in Italy
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Start-Up Visa

Requirements

- Proof of entrepreneurial experience in the declared type of activity
- Income of EUR 8,500 or more in a professional activity for the previous year

- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Requirements

- Remote income of EUR 2.646 plus per month
- Savings in a personal bank account of at least EUR 9,840

Program specifics

- Residence permit is valid for 3 years, with the possibility of extension for 2 years
- To extend, the requirement is to reside for at least 183 days in Spain
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Requirements

- Proof of engagement in an innovative project
- Savings in any bank account to provide for oneself and family for one year in Spain of at least EUR 30,240

Program specifics

- Residence permit is valid for 3 years, with the possibility of extension for 2 years
- To extend, the requirement is to reside for at least 183 days in Spain
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Residence Permit in Bulgaria

Commercial Representative

Requirements

- Owning a company suitable for registering a Commercial Representative
- Place of residence (owned or rented apartment)
- Account in a Bulgarian bank

Benefits specifics

- A residence permit is registered for 1 year, with the possibility of extension
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Residence Permit in Bulgaria

Warranted Retiree

Requirements

- Receiving a retirement benefit outside Bulgaria, preferably not less than EUR 250
- Place of residence (owned or rented apartment)
- Open a personal account in Bulgaria with a balance of EUR 2,500

Benefits and specifics

- A residence permit is issued for 1 year, with the possibility of extension
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years

Residence Permit in Greece

Financial sovereignty

Requirements

- Stable recurring revenue of EUR 2.000 per month outside Greece
- Savings in a personal bank account in Greece of at least EUR 48.000

Program specifics

- Residence permit is valid for 2 years, with the possibility of extension for 3 years
- To extend, the requirement is to reside for at least 183 days in Greece
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years, obtaining citizenship after 7 years of residence

Requirements

- Income of more than EUR 3500 per month
- Copies of bank statement and employment agreement or equivalent document

Program specifics

- Residence permit is valid for 2 years, with the possibility of extension for 3 years
- To extend, the requirement is to reside for at least 183 days in Greece
- Visa-free entry into European countries
- Immigration for the entire family
- Transition to permanent residence after 5 years, obtaining citizenship after 7 years of residence

Residence Permit in Germany

Blue Card Visa (Residence permit for the duration of the agreement)

Requirements

- Higher education certificate
- Employment agreement concluded in Germany + contract for at least EUR 45,300 per year

Program specifics

- Visa-free travel across the Schengen area
- Residence permit for the duration of the contract – maximum 4 years
- Visa-free entry into European countries
- Immigration for the entire family

Fast processing

These types of residence permits, depending on the type and country, are issued within 2-6 months



No investments or large deposits required

These types of residence permits require no investments into the country, but a minimum registration fee is payable



Obtaining permanent residence and citizenship in future

A residence permit allows transition to a stronger status of permanent residence or citizenship after 5 years of residence in the country

In most cases, residency renewal requires residing at least 183 days per year.



Visa-free travel

A resident of an EU country may travel visa-free throughout the Schengen area
